

Rules and regulations of the "PK with my eyes" film competition

Organizer

The organizer of the "PK with my eyes" film competition is the International Relations Office of Cracow University of Technology (PK).

Participants

International students studying at full-time and part-time studies (international exchange) in the summer semester of AY 2020/21.

General rules

1. The subject of the competition are self-made films depicting student life on PK and beyond.
2. Films made in groups are allowed.
3. Films should be submitted by e-mail (iro@pk.edu.pl) or in person to the Organizer of the competition **by 14th June 2021**.
4. The author of the film prepares a statement on the possession of copyrights for the given work and consent to the processing of personal data (Attachment No 1).
5. The three best films will be awarded with diplomas and the following prizes with the PK logo:
1st place - power bank, bag, notebook, keyring
2nd place - thermal mug, umbrella, bag, notebook, keyring
3rd place – USB flash drive, bag, notebook, keyring
6. In addition to the first three places, the organizer allows awarding of a distinction.
7. The awarded and highlighted films will be published on the Organizer's website and in the profiles run by them on social media and on the YouTube channel, as well as used for PK's promotional purposes.

Detailed rules

1. The subject of the competition are short films, the subject of which is related to studies at Cracow University of Technology and student life in Krakow.
2. The technique of making films is optional.
3. Each participant of the competition provides a film(s) with a maximum length of 3 minutes.
4. The contest participant, giving his / her work, confirms that persons whose images are in the film have agreed to publish their images free of charge.
5. The participant agrees to the free publication of his work by Cracow University of Technology for promotional purposes carried out by PK.

Deadlines

Films should be submitted by e-mail (iro@pk.edu.pl) or handed in person by their author(s) **by 14th June 2021**.

Announcement of results and prizes

1. Films will be evaluated by a commission appointed by the Organizer.
2. Participants will be informed about the results by email by 18th June 2021.
3. The best films will be awarded by PK's Vice-Rector for Education and International Affairs, dr hab. inż. Jerzy Zajęc, prof. PK.
4. One film is entitled to one prize regardless of the number of people who participated in its production.

Final provisions

Participation in the competition is tantamount to acceptance of the regulations and the consent of the participant to the processing of his / her personal data in accordance with art. 13 para. 1 and par. 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (general regulation on data protection) Cracow University of Technology informs that:

- 1) the administrator of personal data is Cracow University of Technology with its headquarters in Cracow at ul. Warszawska 24, 31-155 Cracow, Poland;
- 2) contact with the Data Protection Officer at Cracow University of Technology is possible at the following e-mail address: iodo@pk.edu.pl and tel. +48 12 628 22 37;
- 3) personal data will be processed in order to carry out and document the competition;
- 4) personal data will be processed on the basis of art. 6 par. 1 point c of the General Data Protection Regulation and on the basis of:
 - Act of 27 July 2005 - Law on Higher Education (Journal of Laws of 2017, item 2183, as amended),
 - Act of 29 September 1994 on accounting (Journal of Laws of 2018 item 395, as amended),
 - Regulation of the Minister of Science and Higher Education of 16 September 2016 on the documentation of the course of studies (Journal of Laws of 2016, item 1554, as amended),
 - Order No 82 of the Rector of Cracow University of Technology of December 14, 2017 on the introduction of office and archival regulations at Cracow University of Technology;
- 5) personal data will be stored for a period of 5 years from the end of the competition;
- 6) the data subject has the right to access their data and the right to rectify, delete, limit processing, the right to data transfer, the right to object and the right to file a complaint to the President of the Office for Personal Data Protection in the event that data processing personal violates the provisions of the general regulation on the protection of personal data;

7) providing personal data is required on the basis of the legal acts listed in point 4, and the data subject is obliged to provide them at the film submission stage; failure to provide personal data prevents participation in the competition;

8) data processing is necessary to fulfil the legal obligation of the administrator.
